ORDER

Vide paper read (1) above, University had invited applications for Continuation of Provisional Affiliation for the Academic Year 2024-25 from the colleges affiliated to the University. Accordingly, the Principal of St. Joseph's college of Nursing ,Anchal,Kollam had submitted the application for Continuation of Provisional Affiliation to conduct the courses mentioned in table below with intakes mentioned against each.

2. University conducted inspection at the College in order to verify the facilities available for granting Continuation of Provisional Affiliation. The scrutiny committee after verifying the inspection report , recommended to grant Continuation of Provisional Affiliation to the for conducting the following courses with intakes mentioned against each during the academic year 2024-25.

3. The colleges have not submitted INC and KNMC approval for the year 2024-25.

4. The whole matter was placed before the Governing council and the Governing council, vide paper read(2) above, resolved to grant CoPA 2024-25 to St. Joseph's College of Nursing, Anchal, Kollam for the conduct of Nursing Courses mentioned in table above with seats mentioned against each for the Academic year 2024-25, in anticipation of approval from INC & KNMC.

5. In the meanwhile the College has requested to permanently close their MS.Sc Medical Surgical Nursing course due to the unavailability of candidates for the same course and accordingly University vide UO read (3) above has suspended the same course at the College for the Academic Year 2024 - 25 only.

6. In these circumstances, sanction is hereby accorded to grant Continuation of Provisional





Affiliation to St. Joseph's College of Nursing, Anchal Kollam to conduct BSc Nursing Course with an intake of 50 seats for the Academic Year 2024-25 in anticipation of approval from INC & KNMC. If the intake is reduced by any of these council, the same shall prevail.

7. The colleges shall strictly adhere to the general conditions detailed below :-

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.

ii. In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.

iii. Affiliation granted is strictly provisional and is only for the Academic Year 2024-25. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex body concerned.

iv. The Colleges shall remit Annual Administration Fee fixed for UG/PG courses for the Academic Year 2024-25.

v. Admission to the next academic year shall be made only after obtaining prior permissions from the University.

vi. The colleges should submit approval orders from KNMC & INC for the year 2024-25.
