

2. As per clause II (5) of the Ordinance for the inspection in institutions for granting affiliation, 'inspection for granting Continuation of provisional affiliation will be conducted every year till the first batch of the courses/enhanced seats in that institution is passed out and after that, inspection will



- 3. The instituions mentioned in para (1) satisfies the criteria to have inspection once in two years. Accordingly, the matter was placed before the 82<sup>nd</sup> Governing Council. The Governing Council, vide decision read (2) above, resolved to grant Continuation of Provisional Affiliation to the 9 Nursing Colleges mentioned in para (1) for conducting the courses with intakes mentioned against each without conducting Inspection during the academic year 2025-26, in accordance with the provisions in the Ordinance for Inspection in Institutions for granting Affiliation, after collecting the GST on the Application Fee for Continuation of Provisional Affiliation for the Academic Year 2025-26.
- 4. All the above Colleges have remitted the GST on the Application Fee for Continuation of Provisional Affiliation for the Academic Year 2025-26.
- 5. The Colleges mentioned above have not submitted the INC/ KNMC renewal permissions for the Academic Year 2025-26.
- 6. In the circumstances, sanction is hereby accorded to grant Continuation of Provisional Affiliation to the 9 Nursing Colleges mentioned in para (1) for conducting the courses with intake mentioned against each without conducting Inspection during the academic year 2025-26 in anticipation of approvals from INC and KNMC for the Academic Year 2025-26. If the intake is reduced by any of these council, the same shall prevail.
- 7. The colleges shall strictly adhere to the general conditions detailed below:-
- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/ Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.
- iii) Affiliation granted is strictly provisional and is only for the Academic Year 2025-26. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the

University, along with a copy of letter of approval from the apex body concerned

- iv) The Colleges shall remit Annual Administration Fee fixed for UG/PG courses for the Academic Year 2025-26.
- v) Admission to the next academic year shall be made only after obtaining prior permissions from the University.
- vi) The colleges should submit approval orders from INC and KNMC for the year 2025-26.
- vii) The Colleges should admit students to the Management seats in accordance with the Kerala Govt.'s Seat Matrix only, after the issuance of seat matrix from Govt. of Kerala for the Academic year 2025-26.
