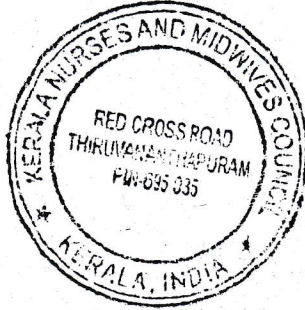
As per reference 1st cited, sanction was accorded to the Principal,

The Commission of the Kerala Nurses and Midwives Council inspected the
institution on 23-03-2018 and submitted report. The inspection report was placed
before the Kerala Nurses and Midwives Council held on 12-04-2018. The Council
resolved to admit the B.Sc. Nursing students during 2018-19 after rectifying the
deficiencies. As per reference 5th cited, the Principal submitted Compliance report.
It was accepted by the Kerala Nurses and Midwives Council held on 29-05-2018 and
it was resolved to accord sanction to admit the B.Sc. Nursing students during
2018-19.
