The St.Joseph's College of Nursing, Anchal is a Christian minority educational institution established, maintained and administered by the St.Joseph's Medical Trust Anchal. The College of Nursing with an annual in-take of 50 students for B.Sc. Nursing was started in 2002. The college is recognised by the Indian Nursing Council (I.N.C.) as well as the Kerala Nursing and Midwifery Council (KNMC) and is affiliated to the Kerala University of Health Sciences (KUHS).

INSTRUCTIONS TO THE APPLICANTS, N.R.I. CATEGORY SEATS (Girls Only)

- Applications for admission to first year B.Sc. Nursing (Academic year 2021-22)
 in the 07 NRI category seats at this college is being invited on the basis of this
 prospectus.
- 2. Duration of the programme shall be four years.
- 3. Medium of Instruction & Examinations: English.
- University Affiliation: Kerala University of Health Sciences, Thrissur (KUHS), Indian Nursing Council (INC), Kerala Nursing and Midwifery Council (KNMC).
- 5. Academic Eligibility: To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with 60% marks under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of Physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note: All applicants must have taken courses in Biology, Physics, and Chemistry in addition to English in the High School Years (during their 10th, 11th and 12th). They should have secured at least 60% marks in Biology, Physics, Chemistry and English at the Plus Two level. Wherever alphabetical grades like A, B-, C+, etc. are used by the school, appropriate equivalence in terms of percentage like 90%, 75% and 60% should be made available.

Only students from high schools accredited by the respective State or the Country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and Equivalency Certificate to this effect shall be produced.

- Age Requirements: Applicants must be at least 17 years of age on 31st December 2021 (the date of birth being shown on the Matriculation or equivalent certificate).
- 7. Eligibility for admission to N.R.I. Category Seats: According to the GO (MS) No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.
- 8. Copy of the following documents duly attested by a Gazetted Officer to prove the NRI status shall be submitted:
 - Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
 - ii. Copy of the relevant pages of the passport containing visa details that is attested by the Embassy.
 - iii. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
 - iv. A self affidavit/declaration (*find specimen format Annexure-1*) by the NRI relative (Sponsorship Certificate).
 - v. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS) No.243/2014/H&FWD dated 06.08.2014.
 - vi. The Candidate shall produce the sworn affidavit from the Sponsor in a stamp paper worth Rs. 200/--The same shall also be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and the all expenses ie, tuition fee and special fee, of the candidate for the entire course period will be borne by the sponsor.

Note: Apart from the schedule of fees given above, the students will be required to pay the proportionate administration/affiliation/examination fee, etc. payable to the University from time to time. Hostel & Mess fee will be charged separately.

10. HOW TO APPLY: Online through College Website

- All applications shall be submitted ONLINE only on the website of the College www.sjcon.org in the following manner. Physical documents are NOT to be submitted at the office.
- 2. Before applying online, candidates should have:
- 3. A valid email ID (If you do not have an email address, we recommend Gmail ID).
- 4. Scanned copy of recent (taken after 1st January 2021) passport size colour photograph. Photograph should be taken in a white/light coloured background. The image should be in JPEG format. Maximum size for photograph 50 KB and image dimension is 120x150 px (4.23x5.29 cm).
- 5. Scanned copy of Student Signature.
- 6. Download the Self declaration form & upload the same by the applicant.
- 7. Scanned copy of the Certificates. The image should be in JPEG / PDF format. Maximum size for JPEG / PDF files 500 KB.

 - TC, Course and Conduct Certificate
 - Aadhar
 - NRI related all documents (Ref.8)
- 8. If documents attached are not legible, the application will be rejected.

The Details of the Application Fee Payment

- 1. B.Sc Nursing NRI Rs: 1000/- (One Thousand Only).
- The application fee can be paid by online payment gateway (Internet Banking, Debit/Credit Cards).
- 11. While reporting for admission, all the relevant certificates/documents in original as listed below should be submitted to the institution:
 - The relevant page of SSLC book/equivalent board certificate as proof of age and date of birth.
 - Certificate and Mark list of SSLC / 10th Std.
 - Certificate and Mark list of qualifying Examination (Plus Two/12th Std.)
 - Certificate of good conduct from the institution last attended (Preferably issued within six months).
 - Transfer Certificate (T.C.)
 - Course & Conduct Certificate.
 - Migration Certificate, if applicable.
 - Conduct certificate from the Head of Institution last studied in proof of clause (Prohibition of Ragging, point 3.2) of this Prospectus.
 - Copy of Photo Id Proof (Aadhar/ Voters ID/ Passport).
 - Copy of the format of online application form.
 - Every candidate before admission to the course shall submit to the Principal of the Institution a Certificate of Medical Fitness from an authorized Medical Officer with MBBS or higher qualification certifying that the candidate is fit to undergo the course.
 - Date of Birth & Name printed Photograph Passport size 8 (No's) & Stamp Size Photograph 4 (No's).
 - Additionally, four sets of photocopies of all the above certificates/documents attested by Gazatted officers have to be submitted at the time of admission.
- 12. As per the regulations of the University and the Regulatory Council, admissions will have to be closed by 31st December 2021 of the year of admission.

After closure of admissions, the seat, if vacated, cannot be filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course. Any complaints in this regard shall be subject to the legal and factual scrutiny and the decision of the ASC/FRC. The colleges shall return the Certificate and TC of these students, on execution of a bond by the student along with any of his/her Parents, undertaking to pay the amount that may be ordered by the ASC/FRC or the Court of Law.

- 13. All students who get selected should get themselves vaccinated against Hepatitis before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 14.Every student is required to adhere strictly to the Code of Conduct of the college.
- 15. Ragging is strictly prohibited. If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 16. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of St Joseph's Medical Trust, Anchal shall be final on all matters with regard to admission.
